Previous Minutes:

Minutes of meeting 3rd February were approved.

Matters Arising:

Meeting 3rd February

Dr Herbert talked of a restriction at the exit from Haymarket Station. **Action** Joanna to contact Roads team.

A discussion took place about toilet provision. **Action** Joanna Mowat to see whether there was a response to her previous questions.

Isabel asked if anything further had happened with Haymarket Terrace re taxis. **Action** Joanna Mowat.

Police Report:

Police Constable Scott advised the main issue was the significant increase in non-domestic break-ins. There needs to be more awareness in the business community. The break-ins had taken place within the last three weeks but had tailed off in the last few days. Small businesses needed to be alarmed with signs saying no cash on site.

Gordon Renton advised that Dr Herbert had said cars were turning left out of Palmerston Place onto Coates Place which is a Green Man crossing. The turning from Charlotte Square to Colme Street was also raised along with cars cutting the corner into Torphichen Street. **Action** Jock Miller to raise these issues with our Councillors.

A discussion took place with regard to legal highs which is becoming an increasing problem.

Following a break-in in another part of the city where it took a day for the police to

arrive PC Scott told the CC there was a diary system for non-serious/urgent calls. This involved a dedicated officer coming at an agreed time.

A discussion took place regarding CCTV in the area. **Action** Jock Miller to raise with West End Association.

Neighbourhood Partnership

Douglas Crescent safety island £5,000 can carry over to the next financial year.

Councillor's Report:

There were no Councillors present however Cllr Rankin had advised he might be late because of Council business. **Action** Jock Miller to make sure they are all aware of issues raised within the meeting.

Correspondence:

HMICS Local Policing Survey was discussed. Those present felt that the police should attend the monthly meetings as it was good to establish a relationship. It was also felt it was a two way relationship. **Action** Jock Miller to respond to survey and direct with Police Inspector Emma Croft saying if they couldn't attend a small report indicating the crimes committed in the previous month.

EACC Workshop 31st January 2015 was discussed. It was decided that the CC did not want to be involved with EACC. It was felt that current arrangements with Gorgie/Dalry and DAAA were working well and that any joint working should be at Neighbourhood Partnership level. Gordon Renton made the point that any joint working that residents should take precedence over businesses every time.
